**Action to be taken: I move the board authorize issuance of the Notice of Intent to Award a Contract and Notice to Proceed to Hellas Construction for the Issaquah High School & Liberty High School Softball Infield Renovations project for \$437,900.00 plus WSST of \$41,600.50 for a total of \$479,500.50.**

Four bids were received for the project. Hellas Construction was the low on the Base Bid. Here are the bid results for the three lowest bids:
