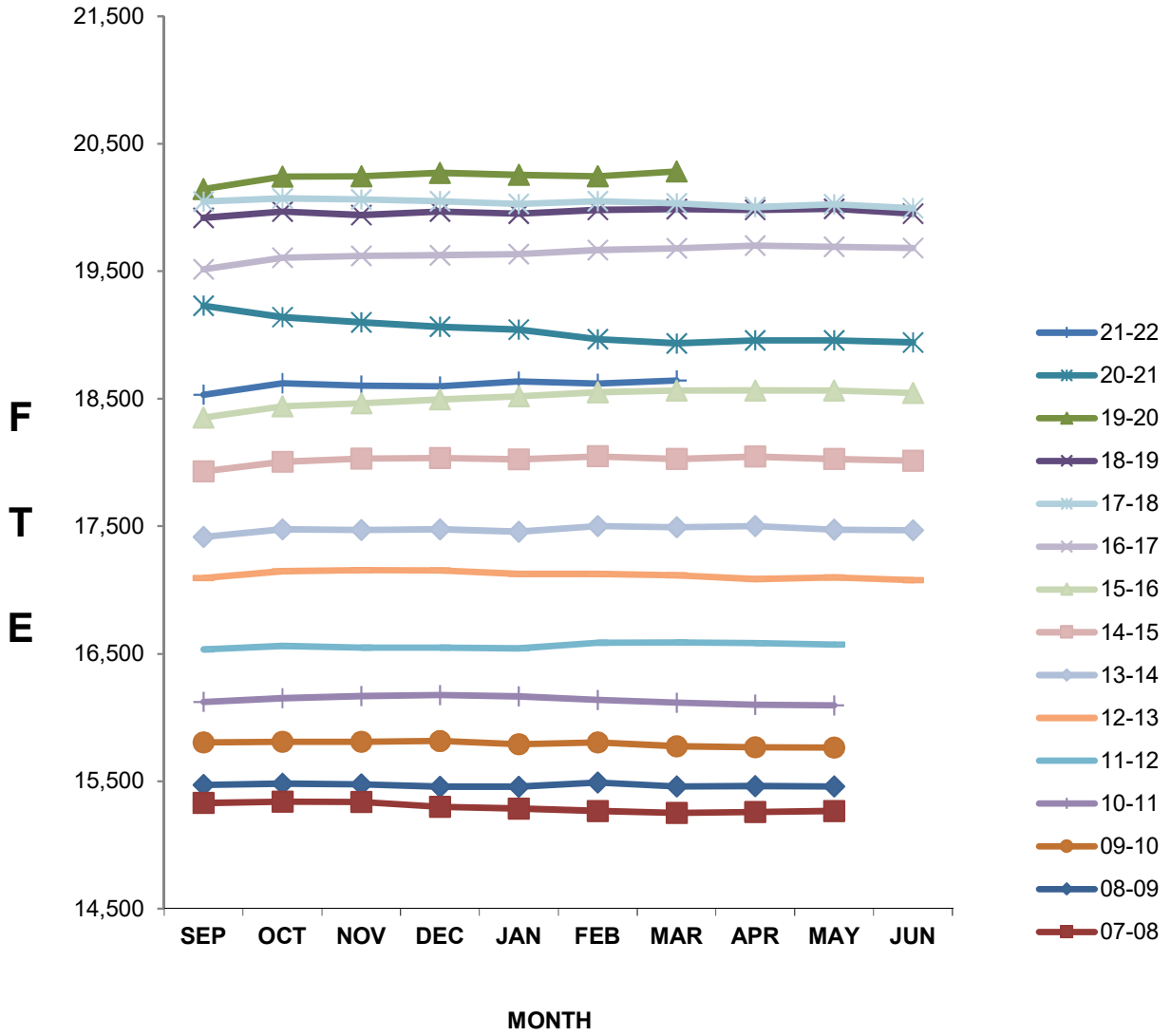

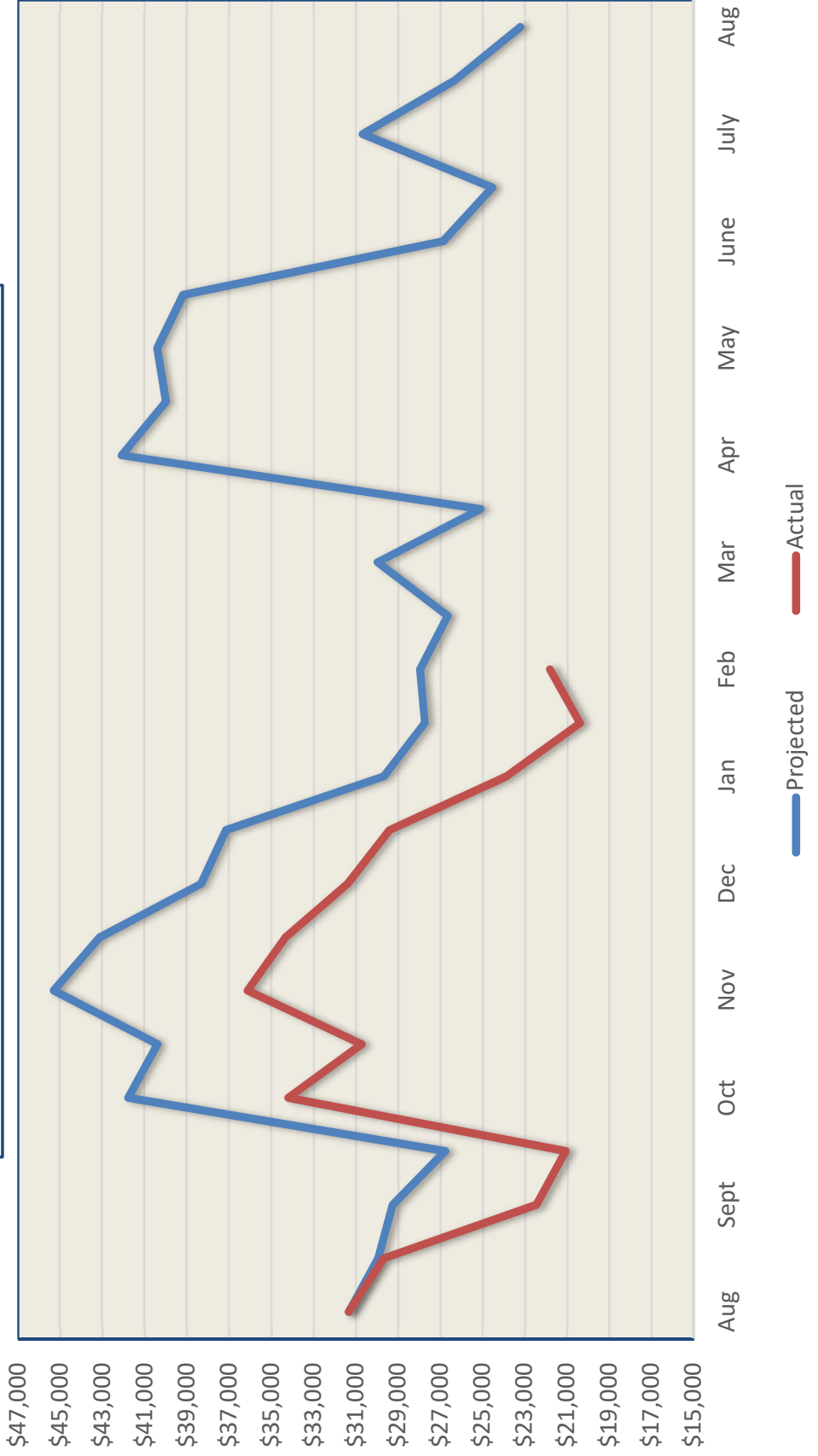

March 1, 2022**

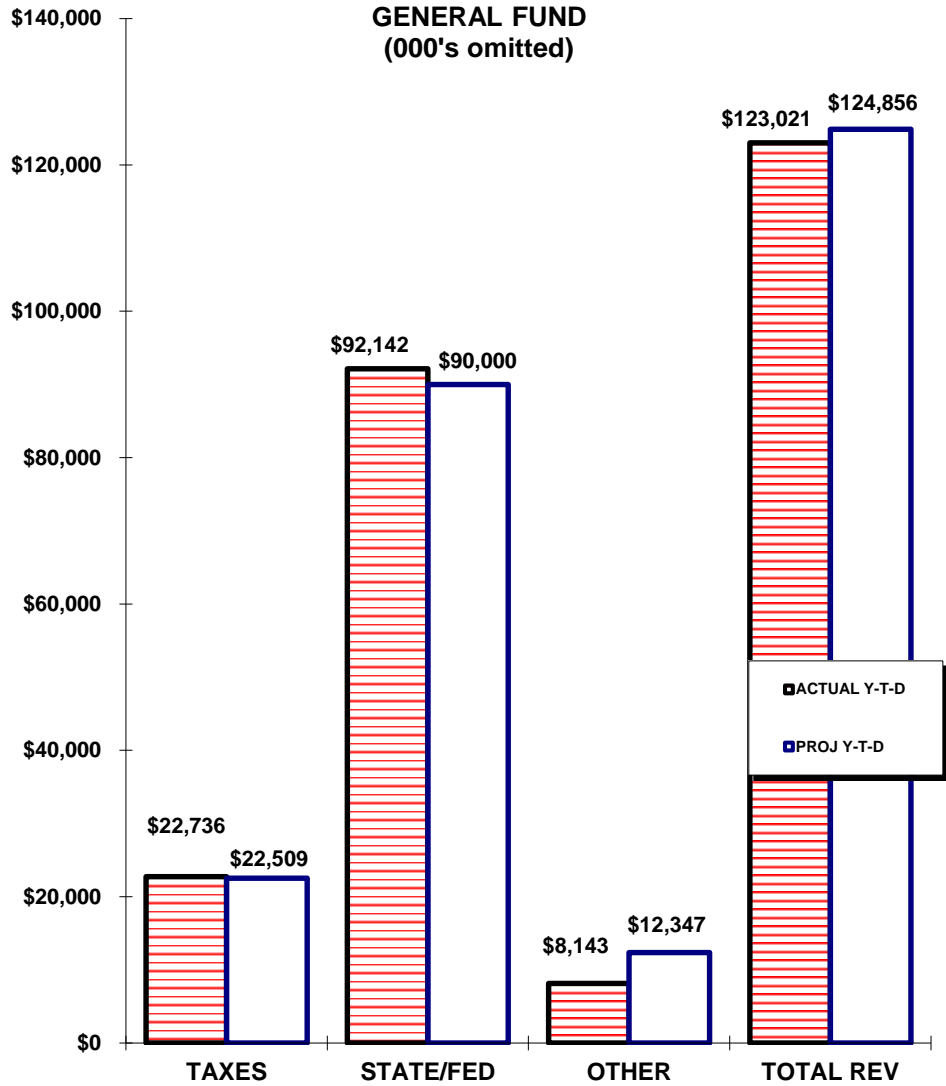

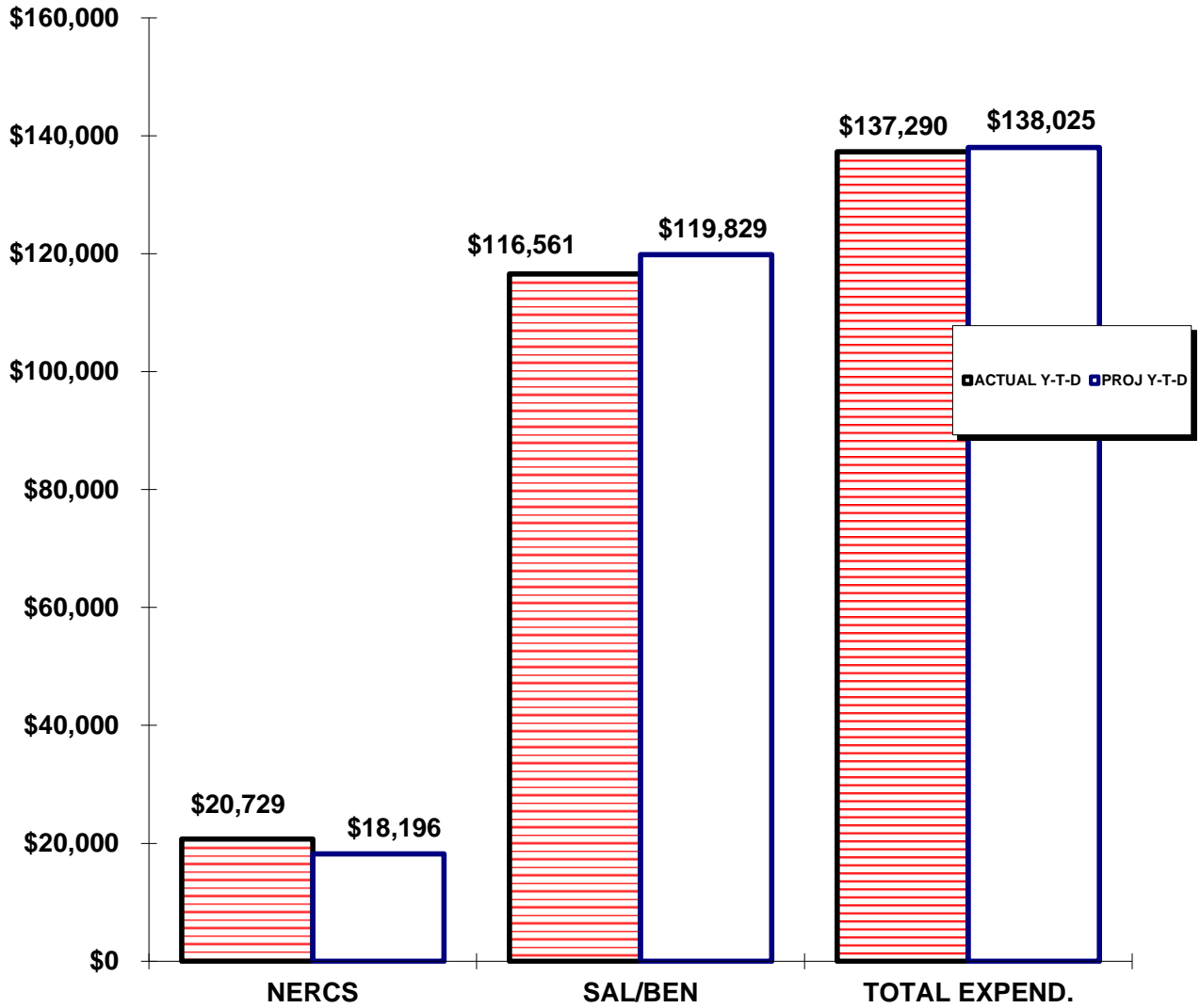
## General Fund Cash Flow 2021-22 (2-28-2022)

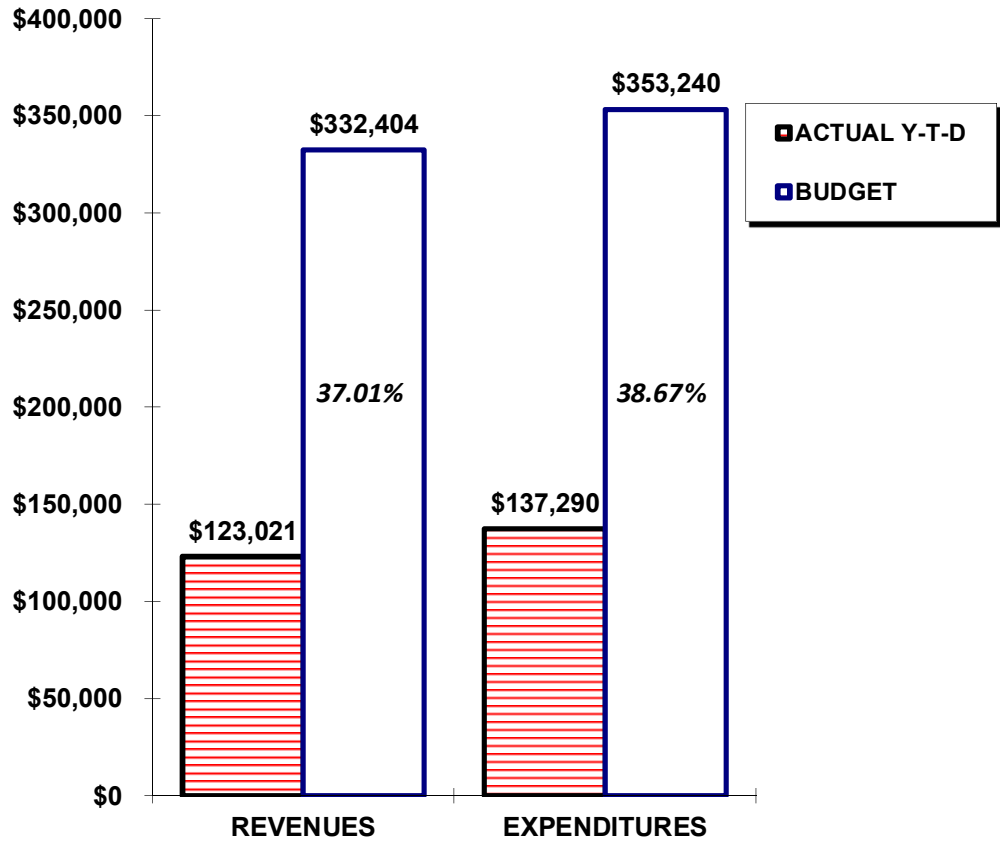

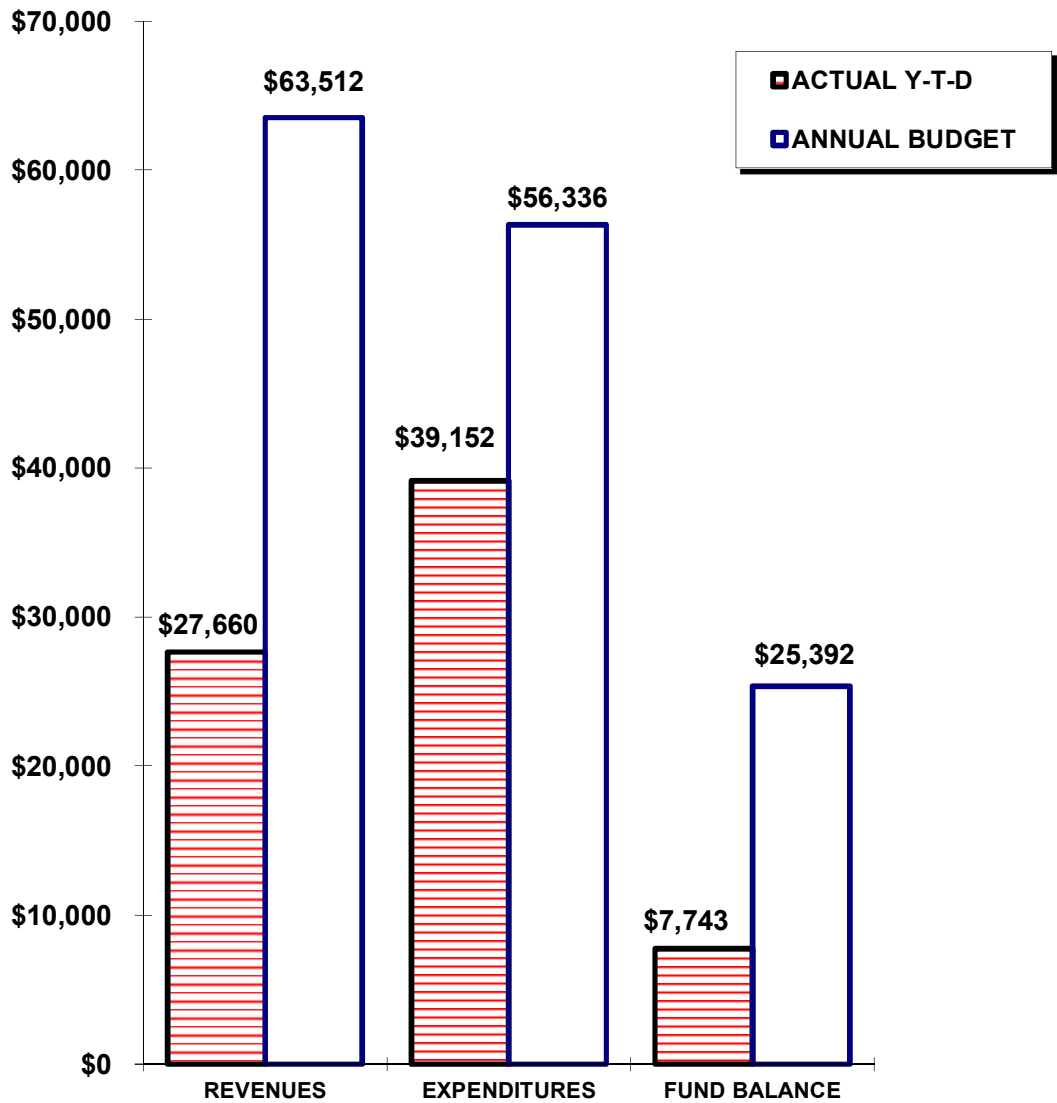
