- The USACE permit was delayed due to unaddressed Muckleshoot Tribe comments.

WDFW received Tribal comments in April 2022, but the comments were never communicated to ISD. When the USACE review was at its end, they realized the Tribal comments still hadn't been responded to. ISD was then alerted and began 3 weeks of communication with The Muckleshoot Tribe regarding plan design. In-water construction should have begun on July 1, 2022, but didn't start until July 21, 2022.
