Holly Street Early Learning Center Playground - Authorization to Issue Notice of Intent to Award Contract and Notice to Proceed - Mullins

Action to be taken: I move the board authorize issuance of the Notice of Intent to Award a Contract and Notice to Proceed to Exxel Pacific Inc. for the Holly Street Early Learning Center Playground project as follows:

> Holly Street Early Learning Center Playground Base Bid is \$630,488.00 plus WSST of \$63,679.79 for a total of \$694,167.29.

> Base Bid, including the alternate costs for the #A-1, Steel Covered Play Structure and #A-3, 6ft Chain Link Fence Replacement the contract amount would be \$782,350.00 plus WSST of \$79,017.35 for a total contract amount of \$861,367.35.

Given the remaining budget, I recommend accepting the bid for the Alternate #A-1 Steel Covered Play Structure #1 and #A-3 6ft Chain Link Fence Replacement alternates.

Three bids were received for the project.
