## **BOARD RESOLUTION NO. 1206**

Adoption of the 2023-24 Budget

**A RESOLUTION** of the Board of Directors of Issaquah School District No. 411, King County, Issaquah, Washington establishing appropriations for the 2023-24 budget.

**WHEREAS,** total budgeted expenditures for each fund as adopted in the budget of a school district shall constitute the appropriations of the district for the ensuring fiscal year; and

**WHEREAS,** the Board of Directors shall be limited in the incurring of expenditures to the amount of each appropriation; and

**WHEREAS**, the Board of Directors shall fix and determine the appropriation from each fund contained in the budget separately and no later than August 31, 2023; and

**WHEREAS,** the Board of Directors shall reduce the excess levy approved by the voters and exceeds the legislative mandated levy lid; and

WHEREAS, the Board of Directors has advertised and held appropriate public hearings;

**NOW THEREFORE, BE IT RESOLVED,** by the Board of Directors of the Issaquah School District No. 411 of King County to adopt the 2023-24 Budget as follows:
