WSSDA Guidelines

- 2023 WSSDA Student Rep Network recommendations to school board (right) strongly recommend an advisory vote
- •WSSDA Model Policy reads: "Student representatives provide the board with advisory votes on agenda items as follows. Immediately before the board votes on an agenda item, the student board representatives will provide their advisory vote whether pro, con, or abstain."

As a Network, we have heard that some boards may be confused or have concerns about advisory voting for student representatives. We would emphasize that the whole reason that a student representative sits on a board is to represent the student body. The opportunity for us to provide advisory votes before the board takes their official vote makes our role more authentic. When student perspective is different than that of the board, there is opportunity to have additional discussion to unpack of why students might disagree. We urge you to add advisory voting to the role of student representatives in your district.


