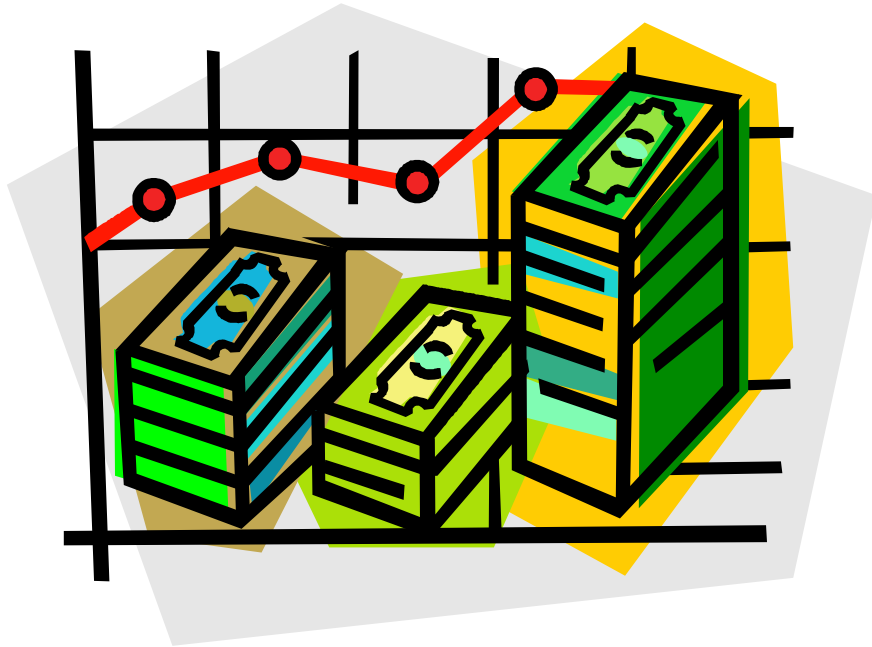

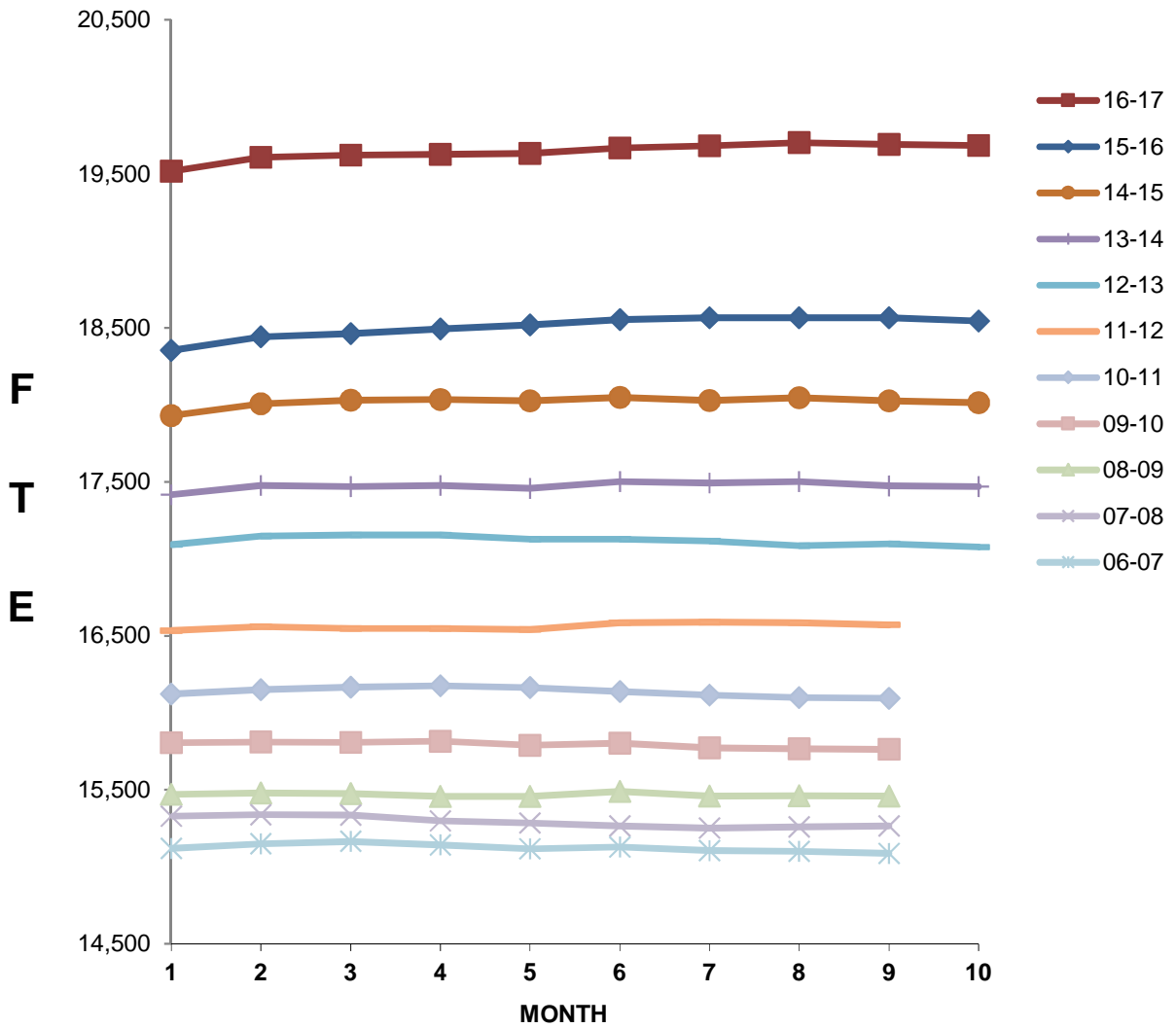

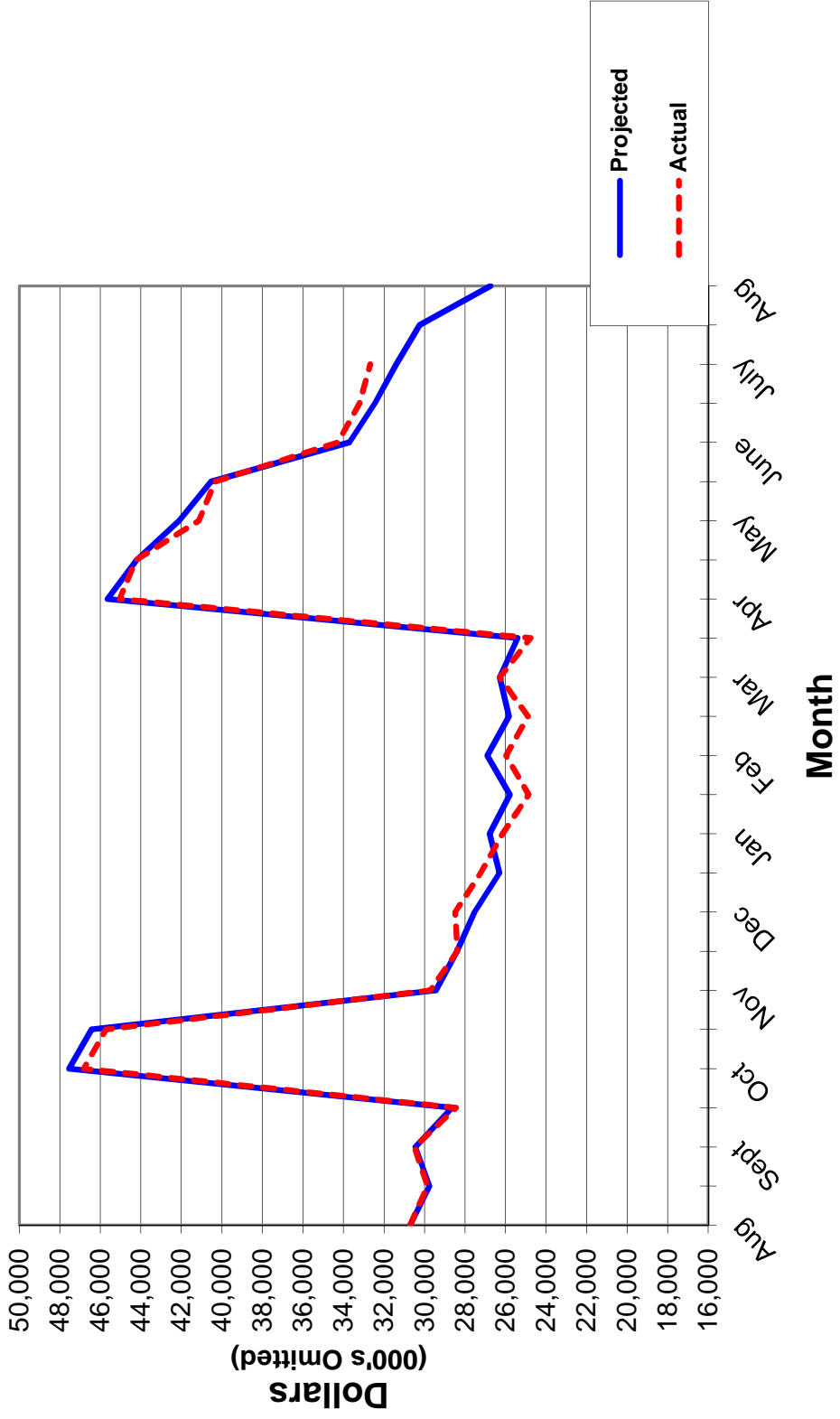

June 1, 2017**

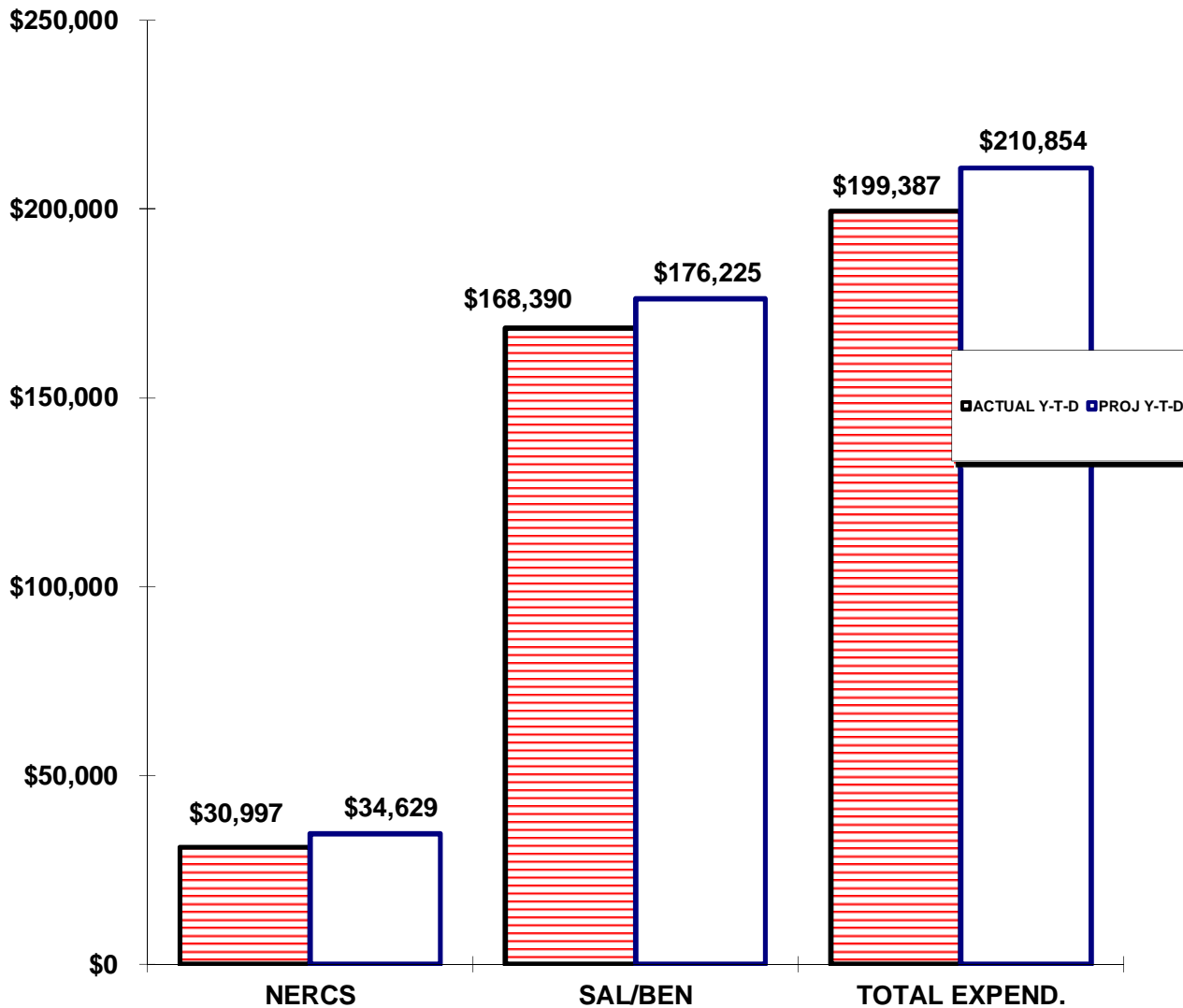

7-31-2017**



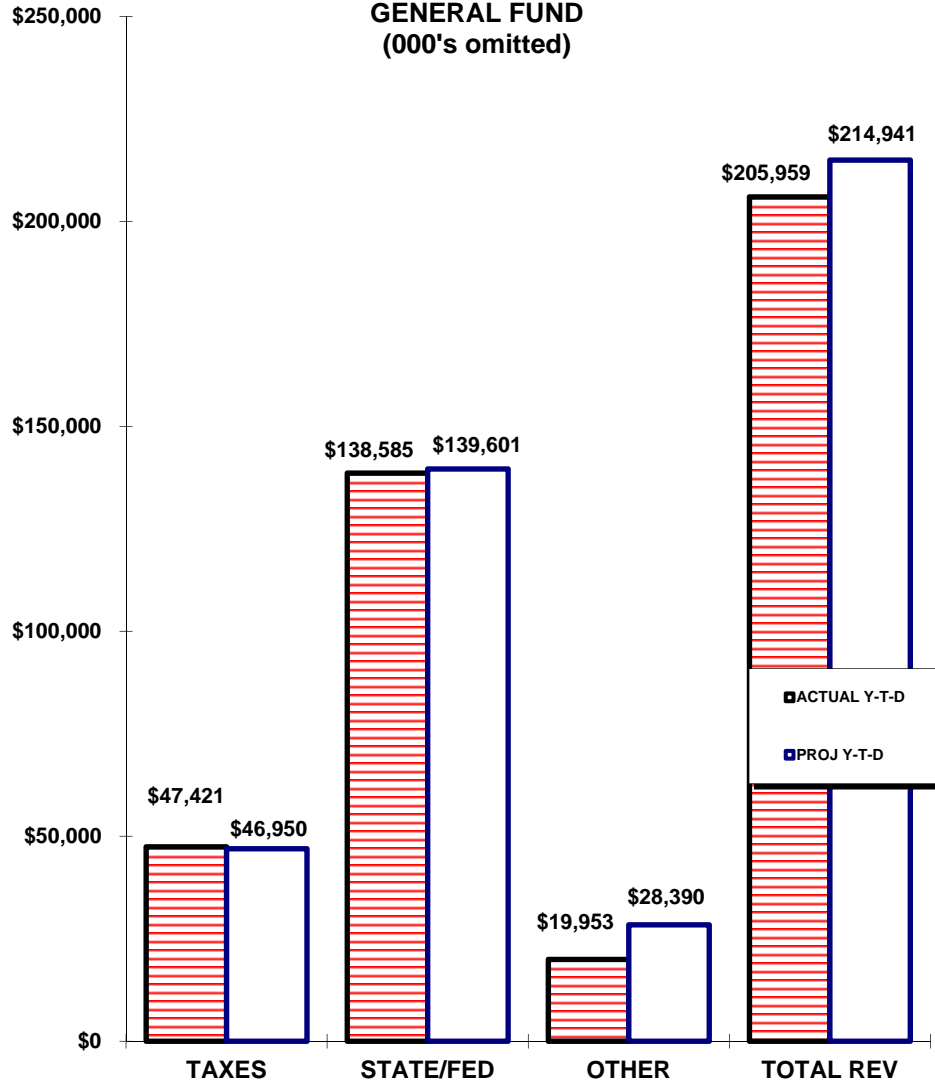

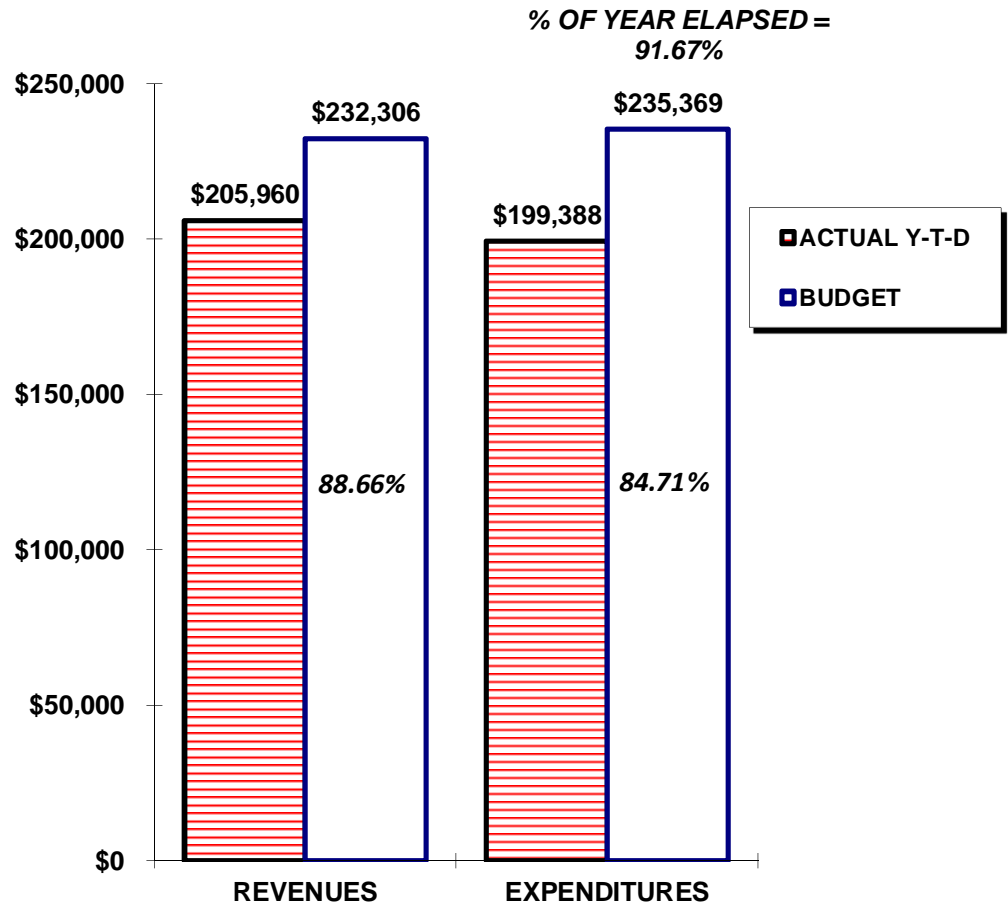

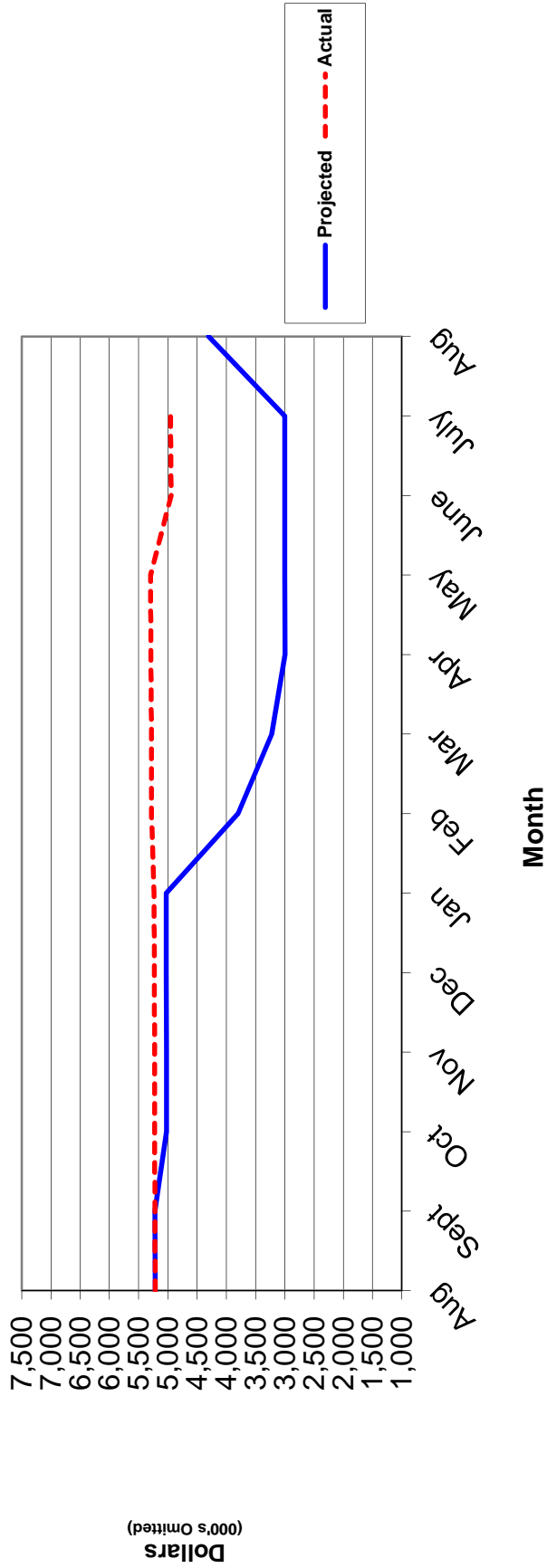
